Airtel Uganda Limited (the “Company”) hereby informs its shareholders and the general public that at the Annual General Meeting (“AGM”) of the Company convened and held by electronic means on **Wednesday 18 March, 2026**, the shareholders of the Company considered and passed the following resolutions:

1. Receipt and approval of the Minutes of the Annual General Meeting of the Company held on 18 March 2025.
2. Adoption of the audited financial statements for the year ended 31 December 2025 and the reports of the directors and auditor thereon.
3. Approval and declaration of a final dividend of UGX 142 billion representing UGX 3.55 per share for the year ended 31 December 2025. The total dividend for the twelve month period ended 31 December 2025 is UGX 446 billion at the rate of UGX 11.15 per share.
4. Confirmation of the appointment of Mr. Neeraj Jain and Ms. Alice Kariuki as non-executive directors of the Company in accordance with Article 152B (j) of the Company’s Articles of Association.
5. Rotation and re-election of Mr. Keith Kalyegira and Mrs. Suzan Mweheire Kitariko as independent non-executive directors of the Company.
6. Re-appointment of M/s Deloitte & Touche as the external auditor of the Company for the financial year ending 31 December 2026, and authorisation of the Board of Directors to determine the auditor’s remuneration.
